What is it?

Legal basis for processing your data

The operations and processing processes described below are based on the applicable legal bases.

Data deletion and retention period

In principle, your data will be deactivated, deleted or blocked as soon as the purpose for which it was stored no longer applies. You have the option to request the deletion of your data by e-mail to <u>info@chryzalid.org</u>. The blocking or deletion of the data takes place after the expiry of the specified storage periods. However, we would like to point out that statutory or legally ordered retention periods may prevent the deletion of data, even at the request of the user.

Retention and backup of your data

Your data will be treated confidentially. By means of appropriate technical and organisational precautionary measures, we protect the data against loss and manipulation as well as against unauthorised access and access by third parties, in particular by means of firewalls and internal and protected data storage.

What personal information does Chryzalid keep?

Main Frameworks for Data Processing

This data is processed within the framework of the stated purpose and for the fulfilment of Chryzalid's mission. This concerns, in particular but not exclusively: Chryzalid membership, project support, partnerships, participation in the committee.

Name, address, telephone number, email address

Your first and last name, as well as your address, email address and telephone number are stored so that we know who you are and can contact you. We also need this data for any correspondence related to our collaboration.

Forms

To use the forms on our site, you must provide your personal data. When the request is submitted, the data from the input mask will be transmitted to us. No other data is stored. The data will not be passed on to third parties without your consent.

Disclosure of your data to third parties

We never share your personal data with third parties without valid reasons, neither in Switzerland nor abroad.

Security of personal data

Chryzalid implements various solutions to strengthen the security of your personal data. Our staff and our partners (IT and website) are aware of the best practices to respect the confidentiality of your personal data.

Chryzalid does not give any guarantee of the infallibility of its own system.

The use of third-party trackers through this website cannot be fully controlled by the Owner, any specific reference to third-party trackers should be considered indicative.

Google Analytics is used and allows the Owner to analyze web traffic and can be used to track user behavior.

Rights of the data subject

You have the right to request information about the personal data we process. In particular, you can request information about the purposes of the processing, the categories of personal data, the planned storage period, the existence of a right to rectification, deletion, restriction of processing or objection, the transmission of the data, the origin of your data if it was not collected from us.
